Both self-insured and fully insured programs can benefit from the network by access to local providers who have joined in an effort to provide low-cost, quality care.

## **HOW TO USE THE PATOKA VALLEY HEALTH CARE COOPERATIVE PROVIDER NETWORK**

---

**Step 1:** Select a Cooperative physician or hospital from the directory. Hospital emergency rooms and outpatient services are not considered a physician's office. If you need assistance with choosing a physician you have two options:

- 1.) Call the Cooperative office
- 2.) Call one of the local contracted hospitals and ask for their physician referral service.

DO NOT assume that each doctor in a group practice is a Cooperative physician unless each is individually listed.

**Step 2:** When phoning for an appointment, verify that the doctor is a Patoka Valley Health Care Cooperative physician.

Identify yourself, or the individual you are scheduling an appointment for, as a Patoka Valley Health Care Cooperative member. Ask if there is anything else you need to bring with you other than your insurance identification card.

Explain your co-payment or co-insurance amount, which your plan requires. Indicate that the physician should file the insurance claim for you. Each physician's office will set up his/her own fee collection policy.

**Step 3:** At the physician's office, always bring your insurance identification card with you.

**Step 4:** When additional medical services are needed:

Ask if all services will be billed by a Patoka Valley Health Care Cooperative provider including laboratory tests, X-rays, or diagnostic procedures.

If a referral to an out-of-network doctor is needed, BE SURE your physician notifies the Cooperative and completes the appropriate referral form prior to your visit to the out-of-network doctor. The Cooperative may guide you to the providers outside the service area who work closely with the local doctors. If hospitalization is required, be sure you are directed by a Cooperative physician. The physician will know whether pre-certification for the admission is required. It is ultimately the employee's responsibility to assure that pre-certification takes place for any procedure that requires pre-certification. Always check to make sure that your physician is referring you to an affiliated facility if you are not admitted to a local hospital.

**Step 5:** If you have questions about either your benefits or a claim, call your employer or your claims processor. The claims processor's phone number is on your insurance identification card. If you have questions about the network or medical management program, please call the Cooperative office.

## **HOW TO USE THE PATOKA VALLEY HEALTH CARE COOPERATIVE MEDICAL MANAGEMENT PROGRAM**

---

The Patoka Valley Health Care Cooperative medical management committee is comprised of representatives from area hospitals, the employer community, physician representatives, and utilization management nurses.

The committee is charged with overseeing the following services performed by the Patoka Valley Health Care Cooperative personnel:

- A. Inpatient admission guidelines
- B. Continued treatment review
- C. Discharge planning
- D. Pre-certification of selected procedures
- E. Second surgical opinion referrals
- F. Retrospective review
- G. Large cost case management
- H. Referrals to out-of-service area providers

The utilization management nurse(s) and the medical and executive directors of the Patoka Valley Health Care Cooperative utilize feedback from this committee to provide locally managed care services to the employees covered by employer plans associated with the Cooperative.
